Recommendation:

• Award the construction services contract to Comstock Construction Inc. of Minnesota in the amount of \$3,213,600 (Base Bid + 7 Alternates)

Background/Key Points:

On April 20, 2020 at 2:00 PM sealed bids were opened and publically read aloud in these Council Chambers. Two (2) bids were received at the closing. The apparent low bidder was Comstock Construction Inc. of Minnesota (Fergus Falls) with a base amount of \$3,028,400.00. The Estimated Probable Construction Cost was \$2,885,000. Bolton & Menk Inc. and City staff evaluated the bids and determined Comstock's bid to be in order and responsive.

Seven (7) bid alternates were included in the proposal form consisting of picnic tables, dumpster enclosures, an irrigation system, along with electrical, water, heating, and overhead door closures for the market place structure. The seven alternates added up to \$185,000. Further detail can be reviewed on the attached bid abstract.

If acceptable, the necessary contract bonding will be secured and the Pre Construction meeting will be scheduled. Construction could begin in the coming month with substantial completion scheduled this fall.

In efforts to maintain access to local businesses and the general public during construction to the most reasonable extent practical, the project has specific disturbance requirements the contractor must abide by. For example, the north half of the west parking must remain undisturbed until the contractor has made satisfactory progress in the plaza area (south half). Once progress has been achieved, the contractor will be able to remove, excavate, and pave the entire parking area. Please note, some removals will occur in the northern parking lot area, but limited to facilitate the electrical power pole relocations.

Given the complexity and location of this project, we want to thank you in advance for your patience and cooperation. The project website will be updated on the City's homepage website and provide key contact information during the construction.

City Council Minutes April 19, 2021

The Fergus Falls City Council held a regular meeting on Monday April 19, 2021 at 5:30 pm in the City Council Chambers. Pastor David Foss gave the invocation and the Pledge of Allegiance was recited. Approval of Agenda

A motion and second were made by Fish and Gustafson to approve tonight's agenda with the addition of authorization for Pedal Fergus Falls to apply for a grant (consent) and a resolution of support for Vector Windows to apply for a Job Creation Fund Application (new business) and the motion carried.

Landmark Designation: 126 W Lincoln Avenue

The Heritage Preservation Commission and Planning Commission have recommended the Victor Lundeen Building located at 126 W Lincoln Avenue be considered a local historic landmark. A public hearing for this designation opened at 5:34 pm. As no one appeared, the hearing was closed. Hagberg offered Resolution #69-2021 designating the property located at 126 W Lincoln Avenue as a local historic landmark, which was seconded by Thompson and was adopted.

Landmark Designation: 423 S Cascade Street

The Heritage Preservation Commission and Planning Commission have recommended the Northern Pacific Depot located at 423 S Cascade Street be considered a local historic landmark. A public hearing for this designation opened at 5:35 pm. As no one appeared, the hearing was closed. Kvamme offered Resolution #70-2021 designating the property located at 423 S Cascade Street as a local historic landmark, which was seconded by Gustafson and was adopted.

Highland Vacation Petition Hearing

A vacation petition has been received for the platted Highland Avenue right of way. This land will be a part of the Otter Tail Power solar farm and no objections have been submitted. A public hearing for this vacation opened at 5:37 pm. As no one appeared, the hearing was closed. A motion and second were made by Hicks and Arneson directing the City Attorney to draft an ordinance for the vacation of the North/South Highland Avenue right of way on Highland Avenue from Main Street to the North Terminus and the motion carried.

CP 5955 Preliminary Hearing

CP 5955 is the reconstruction of the sanitary sewer, water main, storm sewer, sewer & water services and the bituminous street improvements on Bancroft: Cascade Street to Whitford Street and Whitford Street: Alcott Avenue to Channing Avenue. The total project cost is estimated at \$577,433.97. The special assessments are not to exceed a 5% interest rate and would be assessed over 15 years. The hearing was opened at 5:40 pm. As no one appeared, the hearing was closed. Hagberg offered Resolution #71-2021 ordering the plans and specifications and authorizing the advertising of bids, which was seconded by Rufer and was adopted.

Proclamation: Arbor Day

Mayor Schierer read a proclamation declaring April 30 as Arbor Day and the month of May as Arbor Month.

Proclamation: Dollars for Scholars

Mayor Schierer read a proclamation declaring April 28 as Dollars for Scholars Day.

Consent Agenda

The following items were approved under Resolution #72-2021 by Rufer: Motion approving the minutes from the April 5, 2021 City Council meeting and the April 14, 2021 Committee of the Whole meeting. A motion approving a fireworks license for Walmart/TNT Fireworks. A motion exempting the Fergus Falls Youth Soccer Association from field use fees. Resolution #73-2021 authorizing the transfer of FFM Airport Entitlement Funds to the Red Wing Regional Airport. Resolution #74-2021 authorizing the solicitation of quotes and authorizing staff to execute a storm water drainage easement for the property located at 1222 N Tower Road. Resolution #75-2021 initiating PI 5337, the 2021 mill and overlay improvement project and ordering the plans and specifications for this project. Resolution #77-2021 revoking MSAS Route No. 120 and 140. Resolution #78-2021 authorizing Pedal Fergus Falls to submit a grant. The resolution was seconded by Fish and was adopted.

Ordinance 12 Highland Vacation

Ordinance 12, Eighth Series, Ordering the vacation of the Highland Avenue right-of-way in the Guttenberg Addition and a part of Pioneer Road in the Village Cooperative Addition was introduced by Hicks and was declared to have its first reading.

Resolution of Accounts

Fish offered a resolution authorizing the payments and claims in the amount of \$2,823,966.52, which was seconded by Hagberg and was adopted.

Vector Windows Job Creation Fund Application

Vector Windows is proposing the construction of a new facility and they are seeking a portion of the financing through the Minnesota Department of Employment and Economic Development Job Creation Fund. Their project would expand their operations within the city limits and position the company to hire 10-35 employees over the next few years. A resolution of support from the city is a necessary component of the application. Jeff Ackerson of Vector Windows commented on their excitement to continuing building their business in Fergus Falls and his appreciation for the city's consideration with this application. NeTia Baumann of Greater Fergus Falls spoke about the opportunity to support a local business and provide additional jobs in our community. Hicks offered Resolution #79-2021 providing a resolution of support for a Job Creation Fund application in connection with Vector Windows, which was seconded by Fish and was adopted.

After congratulating the Waste Water Treatment Plant staff on their commendation for meeting MPCA standards and the Water Plant's staff for completing the 2020 Water Quality Report, the council adjourned to closed meeting at 5:51 pm to consider a real estate offer pursuant to MN State Sec 13d.05.

Committee of the Whole April 28, 2021

The Fergus Falls City Council met as a Committee of the Whole on April 28, 2021 at 7:00 am in the City Council Chambers. Mayor Schierer called the meeting to order and the following council members were in attendance: Thompson, Arneson, Gustafson, Hicks, Fish, Hagberg and Kvamme. Rufer was absent.

MS4 Annual Meeting

The city is annually required to hold a stormwater management education session with its elected officials. The goal of the stormwater permit is reducing the pollutant levels in discharges and protecting water quality. The MS4, or municipal separate storm sewer system, is a system of roads with drainage systems, municipal streets, catch basins, curbs, gutters, ditches, man-made channels and storm drains operated by a public entity. The City of Fergus Falls, being a community of 10,000 or more, must comply with the standards associated with the collection of stormwater that drains into the Otter Tail River. There are six minimum control measures required by this federally mandated program including:

- Public Education and Outreach
- Public Participation/Involvement
- Illicit Discharge, Detection and Elimination
- Construction Site Stormwater Runoff Control
- Post Construction, Stormwater Management
- Pollution Prevention/Good housekeeping for Municipal Operations

In 2020, the city inspected 81 commercial sites weekly or within 24 hours of 1/2 inch rain event on sties an acre or greater; conducted 454 residential sites inspections; issued 92 verbal warnings for compliance with MS4; inspected 52 of the city's 246 outfalls and mapped 58.27 miles in the city's GIS system. The city's goal is to be reasonable, educational, and fair to all parties. Matt Harrington is the city's MS4 Manager and can be contacted for questions or more information.

Permit for Sales in City Parks

The city has been fielding calls for food trucks and vendors and staff is proposing a permit to allow such sales in city parks. City Code 92.05 allows two days of sales in parks and a \$15.00 fee has been recommended for those needing utilities such as water, sewer and electricity. Vendors wishing to provide food, must also get a permit from the county to ensure food safety standards are being met. The council was reminded of the code regulation of food trucks within the city limits. A motion and second were made by Thompson and Gustafson to recommend the council add a vendor permit for city parks into the fee schedule and the motion carried.

Dog Park Name and Update

The city is proceeding with the construction of a dog park on East Channing Avenue this spring. The fencing and water line will soon be installed and the facility is expected to be opened in June. The parkland on which the dog park is being placed was deeded to the city by the Adams family and their heirs were consulted on the name of the park. They suggested the city name the park Higgins, after the Adam's family pet. A motion and second were made by Kvamme and Fish to recommend the council approve the naming of the park as Higgins Dog Park and the motion carried.

Equipment Purchase

A 2006 Case loader has reached 7700 hours of operation and repairs have become costly. Staff is recommending this equipment be replaced with a new CASE 821G model from Titan Machinery off the Minnesota State Contract. The new equipment price is \$233,510 and a trade-in of \$50,000 for the 2006 model would bring the overall purchase price of \$183,510. The purchase would be funded from the 2021 equipment fund budget. A motion and second were made by Fish and Hicks to recommend the council authorize the purchase of a CASE 821G wheel loader and authorizing the trade-in of the 2006 loader and the motion carried.

Announcements

Yesterday was the softball field number five dedication ceremony at Delagoon Park. Park Board and City Council members were recognized for their contribution and partnership with the Fergus Falls School District for the construction of this field.

PUBLIC HEARING TO CONSIDER A REQUEST FOR AN CONDINATIONAL USE PERMIT (CUP) TO EXPAND AN EXISTING HOSPITAL IN AN R-2 ZONE LOCATED AT 712 CASCADE STREET SOUTH. REQUESTED BY LAKE REGION HEALTHCARE MEDICAL PROPERTIES LLC.

Chair Stanislawski asked City staff to explain the request. Darrin Welle explained that there is currently a medical clinic or hospital on site. The applicate, LRH Medical Properties LLC, is requesting a CUP to expand their building so that they can enclose another cancer treatment vault. The proposed addition does not get any closer to the lot line then the existing building. The proposed building is 1,135 sq.ft. but would only have a single person capacity in the machine. The addition will be no closer to the alley then the existing building, which is 50' away from the neighboring parcels. Darrin explained a some maps and diagrams of the site plan.

Darrin stated that the seven Proposed Findings listed in the staff report were created with the idea of approval of the CUP request with the conditions listed. If the commission does not agree with any of the findings, then the commission should look at are there conditions to help to create a positive finding or look at a denial finding and create a set of findings to support denial.

Darrin stated a condition for the LRH Medical Properties Conditional Use Permit:

1. Must abide by all local and state laws pertaining to the expansion. Including any conditions of prior permits must be followed.

Darrin mentioned that he received an email from Buzz & Ann Lundeen, 117 Channing Avenue East. Are south of the hospital. The Lundeens have concerns about LRH driving pilings into the ground for the expansion of the cancer treatment center. This process can causes a lot of noise and create ground movement that can shake the neighboring houses and cause damage. The Lundeens wanted to make sure that LRH would reimburse neighboring homeowners for any damages to their homes or garages caused by the expansion.

Public Hearing to consider a request for a CUP to Expand an Existing Hospital in an R-2 Zone located at 712 Cascade Street South was opened to the public at 5:35 PM

Chair Stanislawski asked if anyone else wished to speak on this request.

Chair Stanislawski closed the Public Hearing to the Public at **5:36** PM, and bought the meeting back to the Planning Commission for discussion. There was some discussion about liability insurance for the contractor. Commissioner Rachels mentioned it would be a civil matter between the Hospital and property owners.

Commissioner Kilde made a motion to recommend to approve the Conditional Use Permit request by LRH Medical Properties LLC to expand the existing hospital located at 712 Cascade Street South with the condition and the proposed findings as presented. It was seconded by Commissioner Johnson. Passed by the following vote:

PUBLIC HEARING TO CONSIDER A REQUEST FOR VARIANCE TO PLACE A DETACHED ACCESSORY GARAGE WITHIN THE FRONT AND SIDE YARD OF A PROPERTY LOCATED AT 421 FRIBERG AVENUE IN AN R-1 ZONE. REQUESTED BY TERRY & RHONDA CRAFT.

Chair Stanislawski asked City staff to explain the request. Darrin Welle explained that Terry & Rhoda Craft are asking for a variance to place a detached approximate 10' x 16' accessory garage within the front yard of their property located at 421 Friberg Avenue. As this property sits, there is no "rear yard" to place a structure due to the hill on the back of this house. This house was built before city zoning regulations and does not lend itself to detached accessory construction the way the code requires today. This shed was moved on to the property already, but did not require a building permit to move on due to being under 200 sq.ft. in size. The applicant submitted a letter with their application

Darrin explained the ordinances and zoning codes that apply to this variance request in an R-4 Zone. <u>Front yard regulations:</u>

- a) There shall be a front yard having a depth of not less than 30 feet.
- b) There shall be a front yard having a depth of not less than 35 feet on a lot or plot that abuts a thoroughfare as shown on the adopted city thoroughfare plan.
- c) There shall be a front yard on each street side of a corner lot. No accessory building shall project into the required front yard bordering either street.

Accessory Buildings:

- a) A detached accessory building shall not be located in any required front or side yard.
- b) A detached accessory building not over one story and not exceeding 19 feet in height shall have matching facade of the primary structure and shall occupy not more than 30% of the area of any rear yard.

Darrin explained a map of the area and the setbacks required. Darrin stated that Minnesota Statute Section 462.357, SUBD. 6 provides:

- Variances shall only be permitted (a) when they are in harmony with the general purposes and intent of the ordinance and (b) when the variances are consistent with the comprehensive plan.
- Variances may be granted when the applicant for the variance establishes that there are practical difficulties in complying with the zoning ordinance. "Practical difficulties," as used in connection with the granting of a variance, means that (a) the property owner proposes to use the property in a reasonable manner not permitted by the zoning ordinance; (b) the plight of the landowner is due to circumstances unique to the property not created by the landowner; and (c) the variance, if granted, will not alter the essential character of the locality.

Darrin stated that the six Proposed Findings listed in the staff report were created with the idea of approval of the variance request. If the commission does not agree with any of the findings, then the commission should look at are there conditions to help to create a positive finding or look at a denial finding and create a set of findings to support denial.

Public Hearing to Consider a Request for a Variances to Place a Detached Accessory Garage with the front yard of the property located at 421 Friberg Avenue in an R-1 Zone. Requested by Terry & Rhonda Craft was open to the public at **5:41** PM

Chair Stanislawski asked if anyone else wished to speak on this request.

Chair Stanislawski closed the Public Hearing to the Public at **5:42** PM, and bought the meeting back to the Planning Commission for discussion. There was some discussion about the type of shed and siding on the shed. Commission Johnson stated that there is no rear yard to place a structure because of the hill on the lot.

PUBLIC HEARING TO CONSIDER A REQUEST FOR VARIANCE TO ESTABLISH TWO LOTS NOT MEETING THE MINIMUM LOT AREA AND SIDE/REAR SETBACKS LOCATED AT 1901 & 2001 WEST LINCOLN AVENUE IN AN B-6 ZONE. REQUESTED BY WESTRIDGE MALL PARTNERSHIP LLC.

Chair Stanislawski asked City staff to explain the request. Darrin Welle explained that the mall owners are asking for a variance to deviate from the minimum lot area and setbacks of the B-6 zone. Splitting off the stand-alone building will be similar to the area that the tire store operates next door. This will require some parking around the building, but we do not know the intended use of the building yet. There is parking around the structure. Darrin explained a site diagram.

Darrin explained the ordinances and zoning codes that apply to this variance request in a B-5 & B-6 Zones. <u>Setback regulations:</u>

• In a B-5 or B-6, Shopping Center District, there shall be front, side and rear setbacks of not less than 50 feet from all property lines.

Lot area regulations:

• The area of land to be included in a B-5 or B-6, Shopping Center Business District, shall be: more than four acres in a B-6, Sub-Regional Shopping Center.

Darrin explained a map of the area and the setbacks required. Darrin stated that Minnesota Statute Section 462.357, SUBD. 6 provides:

- Variances shall only be permitted (a) when they are in harmony with the general purposes and intent of the ordinance and (b) when the variances are consistent with the comprehensive plan.
- Variances may be granted when the applicant for the variance establishes that there are practical difficulties in complying with the zoning ordinance. "Practical difficulties," as used in connection with the granting of a variance, means that (a) the property owner proposes to use the property in a reasonable manner not permitted by the zoning ordinance; (b) the plight of the landowner is due to circumstances unique to the property not created by the landowner; and (c) the variance, if granted, will not alter the essential character of the locality.

Darrin stated that the six Proposed Findings listed in the staff report were created with the idea of approval of the variance request. If the commission does not agree with any of the findings, then the commission should look at are there conditions to help to create a positive finding or look at a denial finding and create a set of findings to support denial.

PUBLIC HEARING TO CONSIDER A REQUEST FOR THE PRELIMINARY PLAT TO SUBDIVIDE TWO PARCELS OF PROPERTY LOCATED AT 1901 & 2001 WEST LINCOLN AVENUE. REQUESTED BY WESTRIDGE MALL LIMITED PARTNERSHIP

Chair Stanislawski asked City staff to explain the request. Darrin Welle explained that an application has been submitted to the City of Fergus Falls by Interstate Engineering on behalf of the property owner, Westridge Mall Limited Partnership, to plat two parcels of land located at 1901 & 2001 Lincoln Avenue West in Fergus Falls for the proposed sale of the newly subdivided parcel. The property being platted is zoned B-6 (Sub-Regional Shopping Center District). The proposed plat subdivides the parcel into three parcels, one containing the footprint of the retail store "Dollar Store", some adjacent floor space and adjacent parking area, A standalone building along the frontage road that use to be a "Napa", and the other containing the remainder of the existing Westridge Mall footprint and parking lots. Darrin briefly explained some maps and a plat for the request.

Darrin stated that the proposed plat includes the subdivision of two parcels of property currently owned by the Westridge Mall Limited Partnership. The parcel includes both the existing floorplan of Dollar Store and the area to the west of the store as well as planned shared parking, entrances, walkways, hallways, and walls. The other lots contains a stand-alone building along the frontage road that was used as a Napa store. The store is currently vacant. ORDINANCE NO. 7, EIGHTH SERIES

AN ORDINANCE OF THE CITY OF FERGUS FALLS, MINNESOTA, AMENDING CITY CODE CHAPTER 31.08 INTERIM EMERGENCY SUCCESSION.

THE CITY OF FERGUS FALLS DOES ORDAIN:

<u>Section 1.</u> City Code Chapter 31.08, Interim Emergency Succession, is hereby amended to read as follows:

§31.08 INTERIM EMERGENCY SUCCESSION.

(A) *Purpose*. Due to the existing possibility of a **catastrophic event** nuclear attack or a natural disaster requiring a declaration of a state of emergency, it is found urgent and necessary to ensure the continuity of duly elected and lawful leadership of the city to provide for the continuity of the government and the emergency interim succession of key governmental officials by providing a method for temporary emergency appointments to their offices.

(B) Succession to local offices. In the event of a **catastrophic** event nuclear attack upon the United States or a natural disaster affecting the vicinity of the city, the Mayor, Council and City Administrator shall be forthwith notified by any one of **these** persons, and by any means available, to gather at the City Hall. In the event that safety or convenience dictate, an alternative place of meeting may be designated. In the event the Mayor and Council are unable to be present, the Charter Commission shall be notified by any means available to gather at the City Hall or other designated meeting location. Those gathered shall proceed as follows.

(C) Those gathered shall proceed as follows:

(1) By majority vote of those persons present, regardless of number, they shall elect a Chairperson and Secretary to preside and keep minutes, respectively.

(2) They shall review and record the specific facts relating to the **catastrophic event** nuclear attack or natural disaster and injuries to persons or damage to property already done, or the imminence thereof.

(3) They may, based on facts, declare a state of emergency. If a state of emergency is thus declared, then the following provisions in (a) and (b) will be enacted:

(a) By a majority vote of those persons present, regardless of the number, they shall fill all positions on the Council (including the office of Mayor) of those persons upon whom notice could not be served or who are unable to be present.

(b) Interim successors shall serve until a time as the duly elected official is again available and returns to his or her position, or the state of emergency has passed and a successor is designated and qualifies as required by law, whichever shall occur first.

(**D**) *Duties of the Interim Emergency Council.* The Interim Emergency Council shall exercise the powers and duties of its offices and appoint other key government officials to serve during the emergency.

said ordinance was published and the above filing shall be performed by the City Administrator when the benefited parties have paid the expenses of this proceeding.

Background/Key Points:

The Ballweg's who reside at 2306 Southview Drive approached the City about purchasing some of the undeveloped City-owned property between their home and the City's water reservoirs for the construction of a private garage/shop.

The City has asked a local realtor to perform a market analysis, which supports the proposed purchase price of \$35,000 for this parcel. The Ballwegs have paid for a survey of this area, so a boundary and legal description have been established. If the transaction proceeds, this parcel will be combined with the existing residential parcel to create a large parcel. Any future use of this property will have to comply with City Zoning ordinances for this area.

If the City Council wishes to proceed with this transaction, a resolution introducing this land sale should take place tonight and then at our next meeting, additional action can make this official. Per the City Charter, selling City property requires action at two separate meetings, with 10 days in between, allowing the public ample opportunity to comment on the proposed action.

The City does not have any future plans for this undeveloped property. There are some utility challenges in this area, with no sewer main extensions serving this area. The buyers will be responsible for utility extension costs.
