## Overview

The City of Fergus Falls has undertaken a continuation of the Downtown Riverfront Improvements Project. This project will be in the parking lot east of the market pavilion. This project will include the construction of a splash pad, restroom, decorative concrete, utilities, and landscaping that is meant to continue the ideas behind the market pavilion project and create additional public spaces.

## Closure

Starting **Friday, May 12**, crews will close the south half of the parking lot. A construction fence will be placed down the center of the lot to provide working space during construction. An informational map is on the reverse of this sheet.

## Construction

Over the next few weeks, Otter Tail Power Co. will bury power lines. Contractors will also be starting pavement removal and work on the foundation systems for the various structures.
